3) Insurance Coverage

- We were notified in May 2017 that we would be losing our Directors and Officers insurance and the insurance company sent a final notice end of July 2017. Our D&O insurance was late paid \$535 policy NFP0127663-00 via an electronic check from Wells Fargo and in the process of getting put back in full force.
- Hope to receive a copy of the D&O policy within two weeks or less.
- Our Business Liability policy was canceled by Hartford March 27 2014 for non-payment. That has been reinstated effective December 5 2017 for \$360.36 policy # 42SBMBA6882 – 001, paid via debit card.

- Trying to get both policies placed on an email notification system, in addition to getting updated copies of the policies.
- Also trying to work through the issues with ISACA and Willis Group for any specific inclusion on the overall E&O policy. We may be covered with the D&O but need the policy to determine that. E&O policies run from \$1,500 to \$3,500 per annum
