- **HALF-YEAR, HALF-PRICE MEMBERSHIP OFFER**
  - The months of June and July mark ISACA’s annual “half-year, half-price” membership offer. During this time, ISACA reduces the cost of professional member dues from US \$135 to US \$67.50 to provide, in essence, a six-month membership price. In 2018, ISACA is expanding the existing offer to include recent graduates at the six-month rate of \$33.75.
  - Historically, chapter dues have remained full price during the “half-year, half-price” membership drive. This year, we are asking chapters to join us in a pilot program wherein they agree to reduce chapter dues by half for both professional and recent graduate members for the months of June and July. ISACA believes this will greatly strengthen the incentive and, in turn, bring more new members to ISACA.
